





All non-EU/EEA and UK nationals are required to register with the Garda National Immigration Bureau (GNIB) within 30 days of their arrival in Ireland. Internships

The University will secure internship opportunities for students enrolled on programmes with an internship component. However, shortlisting for internships is at the discretion of the employer. For students who do not secure an internship an alternative module will be offered in lieu of this component to successfully complete the programme.

Methods of Payment

International students can pay their deposit or tuition fee from their home country in one of two ways:

Option 1: TransferMate

Students from beyond the EU/EEA and UK should pay their tuition fee through the TransferMate website https://universityofgalway.transfermateeducation.com/. TransferMate payments usually take less than 48 hours and the receipt is accepted as proof of payment of tuition fees by the Irish National Immigration Service (INIS) for study visa applications and at the point of entry to Ireland. TransferMate also avoids international bank charges and as you pay in your own currency, the University receives the exact amount owed.
