- 6. Teaching and Responsibilities: Teachers are expected to teach assigned subjects diligently, complete the syllabus on time, and strive for excellent student outcomes while incorporating ICT tools and innovative teaching methods.
- 7. Student Relations: Treat students with respect and fairness, considering their diverse needs, promoting their personal and community development, and providing guidance beyond class hours without seeking rewards.
- 8. Ethical Boundaries: Refrain from developing undue familiarity with students or inciting them against others. Avoid private tutoring or coaching that conflicts with institutional duties.
- 9. Community Engagement: Teachers should participate in community activities, promote national integration, and encourage students to respect authority, property, and the environment.
- 10. Collaboration with Parents: Maintain communication with students' guardians, providing performance reports and engaging in meetings to mutually benefit the institution and the students.

CODE OF CONDUCT FOR NON-TEACHING STAFF
