





#### III. Content


The content is prepared using the books available from the college library and also online resources. The medium of instruction to be used will be English. General reading regarding various other philosophers and thinkers would be encouraged.





c. The College will promote the course among its students and encourage their participation.

d. Ms. Mamata Meghnani, Coordinator, B.A.F., will be Coordinating with DVA for the entire course.

- 5. Duration: This MOU is valid for the academic year 2022-23.
- 6. Termination: Either party may terminate this MOU by providing written notice to the other party at least 30 days prior to the desired termination date.

#### I. Intended Learning Outcomes

The course will help the students to gain an understanding on the concepts related to stock market which will further include concepts like Financial Instruments, Investment Analysis, Risk Management, Stock Market Trading.

#### II. Context

The context for a short-term certificate course in the stock market is to provide participants with a basic understanding of the stock market. The course targets to equip students with required knowledge and skills to make informed investment decisions. The course is designed to cater to students across various departments who have a special and genuine interest in the stock market but may not have extensive prior knowledge or the ability to commit to a longer-term program.

The course will be of 30 hours and will have 40 students maximum in one batch. Lectures Would be conducted in hybrid mode.

#### III. Content

This Short-Term Certificate Course on Stock Market Basics & Trading is designed to help participants with an in-depth knowledge of the stock market and equip them with the required knowledge and skills to make timely & informed investment decisions.

#### IV. Teaching Methodology

Sessions will be conducted both online & offline. Zoom platform will be used in case of online and offline lectures will be conducted using projectors, smart boards. Apart from powerpoint presentations, Youtube videos, LIVE market experience will be provided to the students.

## V. Assessment & Evaluation Methods

During the course, students will be asked to give presentations on simple topics or topics already covered. At the end, one final test based on MCQ pattern will be conducted. The passing criteria for the test would be 40% and evaluation would be done on that basis.

From being a think tank, ATLMRI has evolved to research ecology, with school of thinking orientation and more emphasis being laid on scholarly rigor. It is a research and policy advocacy programme that aims to analyze and understand growth trajectories in the Indian economy and the character of labour force. We visualize providing pivotal linkage between the government, industries, education-training providers, and prospective employees.

As a think tank, the Labour Market Research Facility (LMRF) has been actively pursuing research on macro labour markets, informal employment, and skill development. While the LMRF team produces and disseminates research on salient aspects of the labour market, there have been systematic endeavors by the team to promulgate the idea of decent employment through skill formation by collaborating with four colleges in Mumbai. Industrial Relations is the another critical area that has been explored by the LMRF for research and public policy advocacy. During the last academic year, the LMRF organised workshops on informal employment, involving workers' representatives, the state and other stakeholders. Moreover, the LMRF has also been providing tabulated large sample survey unit level data for some of the major projects undertaken by the Institute. #### PAR

According to industry survey, only 10 percentage of new graduates in India are considered 'employable'. Most of the study reveals that students are lacking employability skills and the attitudes that enable to get along with colleagues to make critical decisions, solve problems, develop respect and ultimately become strong ambassadors for the organization. As a research organization, understanding the need of youth and need of the hour, LMRF initiated a pilot skill development programme to help students to develop aptitude, logical thinking, analyzing and researching their activity to produce quality output. PAR is 45 hours of programme designed for the final year students to enhance their capability and find a good employment. This course will be imparted along with their academic studies and will help them to improve and implement their studies. PAR will cover an additional personality development and leadership qualities training at the end of the course for the students who need the training in those areas.

#### Background:

India will be one of the youngest countries by 2020 and the median age will be 29 years. whereas China and the U.S. are 37 years. India, is among the youngest countries in the world only 2% of the total workforce in India has undergone skills training. With 700 universities and more than 35,000 affiliated colleges enrolling more than 20 million students, the Indian system of higher education is the third largest in the world, after those of the US and China. India has a great opportunity to meet the future demands of the world. The challenges for India get magnified, as it needs to reach out to the million-plus workforce ready population while facing an ever-increasing migration of labour from agriculture to manufacturing and services.
