Dear Sir,

I am writing this with reference to your application No. SNMS/College/85/1, dated 26th November, 1985, for affiliation of a College of Commerce proposed to be started by the Samiti at Chembur, Bombay, for the teaching of the courses of study for the F.Y.B.Com. examination from the academic year 1986-87.

In this connection I am to inform you that the report of the local inquiry committee was placed before the Academic Council at its meeting held on 7th May, 1987, (vide item No.5) for its consideration. The Academic Council considered the said report and resolved as under :-

"It was resolved that it be reported to the Executive Council, that in the opinion of the council, the Narayana Mandira Samiti's College of Commerce, Sree Narayana Marg, P.L. Lokhande Marg, Chembur, Bombay-400 089, be affiliated for teaching of the courses of study for the First Year B.Com. examination in the following subjects for a period of one year with effect from 20th June, 1986 :-

F.Y.B.Com.

Foundation Course-Paper I;
Business Communication;
Business Economics-Paper 1;
Commercial Geography;
Mathematical and Statistical Techniques;
Accounting and Financial Management Paper I;

subject to the immediate fulfilment of the following conditions to the satisfaction of the Executive Council :-

That the college authorities have given an undertaking in writing:

(1) that they will spend Rs.15,000/- for the purchase of library books and journals during the year 1986-87;

(2)(a) that they will ensure that the quota reserved for backward classes for posts in teaching and non-teaching categories is filled up and report is submitted with effect to the University;

(b) that they will appoint requisite teaching staff including the Principal and submit

- (3) that they will appoint a Librarian as per the University rules;
- (4) that they will provide a suitable room for the staff and students;
- (5) that they will deposit the first instalment of Rs.20,000/- for Reserve Fund in the nationalised bank in the name of Trustees and will execute an irrevocable trust deed in the name of nominated trustees;
- (6) that they will appoint qualified teacher for the subject Statistical & Mathematical Techniques;
- (7) that they will provide adequate number of tutorial in Business Communication;
- (8) that they will make appointments of the Principal and other staff with duly observing selection Committee procedure;
- (9) that they will constitute Local Managing Committee and convey regular meetings;
- (10) that they will hold F.Y.B.Com. examination as per University guidelines;
- (11) that the Society will meet the deficit of the college, if any.

Further, it be recommended to the Executive Council that the college be permitted to have one division of F.Y.B.Com. class with not more than 100 students during the academic year 1986-87. No additional division should be opened without prior approval of the University."

The above resolution of the Academic Council was placed before the Executive Council at its meeting held on 29th June, 1987 (vide item No.26) for its consideration when the Executive Council postponed the consideration of the said resolution and decided to call for compliance report in respect of the fulfilment of the conditions laid down by the Academic Council.

I am, therefore, to request you to kindly give compliance report in respect of each of the conditions mentioned in resolution of the Academic Council quoted above immediately on receipt of this letter. A copy of the report of the local inquiry committee is enclosed herewith for ease of reference.

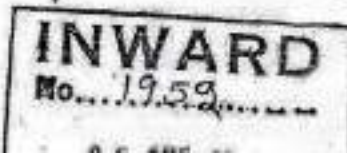

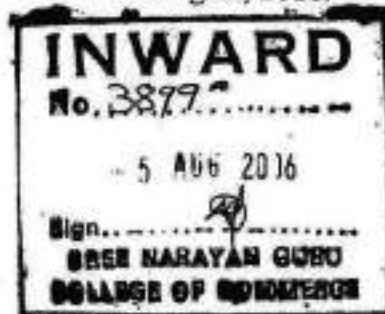


